In the Government order read above, orders were issued for appointment of Thiru C. Ponnaiyan, as Vice-Chairman in the State Planning Commission.

2. The Government now issue the following terms and conditions for the post of Vice-Chairman, State Planning Commission.

- (i) He will have the status of a Minister of Tamil Nadu
- (ii) The Vice-Chairman will be eligible for Salary, Telephone facilities, Motor Vehicle, Medical Concessions, Supporting Staff, Travelling and other allowances as per entitlement for the status of the Minister.
- (iii) The Vice-Chairman will be allowed to draw his Salary, Travelling Allowance and other bills from Pay and Accounts Office (East), Chennai-8.
- (iv) The Vice-Chairman will have a tenure which is Co-terminus with term of the present Government or until further orders, whichever is earlier.
