### ORDER:

In the Government order first read above, orders have been issued appointing Thiru C.Ponnaiyan as Vice-Chairman, State Planning Commission.

2. In the Government order second read above, orders have been issued according the status of Minister to the Vice-Chairman, State Planning Commission.

3. In the letter third read above, the Member Secretary, State Planning Commission, has requested sanction of posts as eligible to the rank of Minister and also requested that it be given effect from the date of assumption of office of the Vice-Chairman i.e. 12.03.2020 and stated that the posts be filled up as per discretion of the Vice Chairman.

4. In continuation of the Government order second above, Government hereby issue the following terms and conditions for the post of Vice-Chairman, State Planning Commission:

1) Sanction is accorded for the following posts by temporarily creating the posts of personal/attendant staff to the Vice-Chairman, State Planning Commission co-terminus with the tenure of the Vice-Chairman as applicable to the post of Minister, Government of Tamil Nadu from the date of assumption of charge.

**Note:**

- i) Driver post – one post is Departmental Driver and another post is Outsider Driver.
  - ii) Office Assistant posts – 2 posts are Departmental OA (Permanent post) and another 2 posts are outsider OA posts.
  - iii) Department posts are to be filled up through Existing persons in Service from Government Departments/Public Sector Undertakings and Outsider posts at the discretion of the Vice-Chairman.
- 2) The Vice-Chairman is eligible for the Salary equal to that of Minister.
  - 3) The Vice-Chairman is eligible for residential telephone facilities with total exemption (No ceiling on free calls).
  - 4) The Vice-Chairman is allowed to have vehicle with reference to the norms prescribed vide G.O.Ms.No.232, Home (Transport.IV) Department, dated: 15.03.2017. (Orders for purchase of vehicle has accordingly been issued vide G.O.Ms.No.17, Planning, Development and Special Initiatives (SPC) Department dated: 19.3.2020)

- 5) The Vice-Chairman is eligible for medical concessions applicable to the highest category of civil servants employed under the Government of Tamil Nadu.
- 6) The Vice-Chairman is eligible to tour within and outside the State on official purposes and to draw Travelling Allowance and Daily Allowance at the rates applicable to the Minister.
- 7) The Vice-Chairman is eligible for mobile phone and Wi-fi charges as applicable to the Minister.
