ORDER:

In the reference first read above, the Government of India has released the re-validated unspent balance amount lying with the State as on 01.04.2020, to be spent during the financial year 2020-21 to the tune of Rs.24.22 lakhs for meeting the expenditure on Salary, Office Expenses, Honorarium, Tabulation and PSI components under Central Sector Scheme "Agriculture Census Scheme" during the year 2020-2021.

2. In the reference second read above, the Commissioner, Department of Economics and Statistics has requested the Government to accord early sanction of Rs. 11.00 lakhs (Rupees Eleven lakhs only) under the head of "Honorarium" (i.e. Rs.9,60,200/-for Honorarium and Rs.1,39,494/- for tabulation work) that has been released by Government of India. Honorarium and Tabulation for two districts viz., Nagapattinam and Madurai have not claimed during 2019-20 as given in the table below:

- 3. The Government after careful examination, accord sanction for a sum of Rs.9,60,200/- and Rs.1,39,493/- Totally Rs. 10,99,693/- (Rupees Ten lakhs ninety nine thousands six hundred and ninety three only) to meet out the expenses for Honorarium which includes the Tabulation work for the Tenth Agriculture Census for the two districts viz. Madurai and Nagapattinam.
- 4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:

Pending provision of such funds, the Commissioner, Department of Economics and Statistics is authorized to incur the expenditure sanctioned in para-3 above. The expenditure shall be brought to the notice of Legislative by way of specific inclusion in the Supplementary Estimates. The Commissioner, Department of Economics and Statistics is requested to include the above expenditure while sending budget proposals for RE / FMA 2020-2021 and also requested to send necessary explanatory notes for Supplementary Estimates 2020-2021 to Government in Finance (BG-I/Public) Department at the appropriate time without fail.
