- (iv) Municipal Administration and Water Supply Department
- (v) Public Works Department
- (vi) Energy Department

5. Planning, Development and Special Initiatives Department will function as the convening Department. Tamil Nadu e-Governance Agency will co-ordinate in preparation of the review materials and assist the concerned departments to update the progress of the schemes through the web-portal (e-Munnnetram).

6. The High Level Official Committee shall meet once in two months to review the progress of works taken up under Major infrastructure Projects.
