## ORDER:

In the Government Orders first and second read above, orders were issued that the Government of Tamil Nadu would sanction matching grant equal to the amount sanctioned by the Indian Council of Social Science Research (ICSSR) to the Madras Institute of Development Studies, Chennai every year.

- 2. In the Government Order third read above, Government formulated certain procedure for sanction of matching grant to Madras Institute of Development Studies, Chennai instead of sanctioning block grant.
- 3. In Government Order fourth read above, Government has sanctioned and released a sum of Rs.156.45 lakhs being the (2<sup>nd</sup> instalment balance + 3<sup>rd</sup> and 4<sup>th</sup> Instalments (Rs.13.65 lakhs +Rs.90.50 lakhs + Rs.52.30 lakhs) as matching grant to Madras Institute of Development Studies, Chennai for the financial year 2017-2018 from out of the funds provided in BE 2018-19.
- 4. In Government Order fifth read above, Government has sanctioned and released a sum of Rs.52.30 lakhs being the 5<sup>th</sup> instalment of salary and general grant for the financial year 2017-2018 to the Madras Institute of Development Studies Chennai as matching grant pending provision of additional funds of Rs.15.75 lakhs in RE/FMA 2018-2019.
- 5. In the Government Order sixth read above, Government has sanctioned and released a sum of Rs.10.00 lakhs being the additional grant for the year 2017-2018 to the Madras Institute of studies Chennai as matching grant, pending provision of additional funds of Rs.10.00 lakhs in RE/FMA 2018-2019.
- 6. In Government Order eighth read above, Government has sanctioned and released the State's matching share for a sum of Rs.67.00 lakhs (Salary Grant Rs.57.00 lakhs + General Grant Rs.10.00 lakhs) equal to the amount released by the Indian Council of Social Science Research, New Delhi as the first quarter instalment to the Madras Institute of Development Studies towards grant in aid for the year 2018-2019.
- 7. In Government Order nineth read above Government has sanctioned and released the State's matching share for a sum of Rs.148.00 lakhs being the 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> instalments for the 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> quarter of 2018-2019 equal to the amount released by the Indian Council of Social Science Research, New Delhi as the first quarter instalment to the Madras Institute of Development Studies towards grant in aid for the year 2018-2019.

- 8. The ICSSR in its reference tenth read above had fixed a sum of Rs.259.00 lakhs (salary grant Rs.204.00 lakhs + General grant Rs.55 lakhs) as its share for the year 2018-2019 to be released in 4 instalments. Out of Rs.259 lakhs fixed by the ICSSR, as its share for the year 2018-2019, the Government has so far released a sum of Rs.67.00 lakhs, vide G.O. 8<sup>th</sup> read above and Rs.148.00 lakhs vide G.O.9<sup>th</sup> read above for the year 2018-19, totalling Rs.215.00 lakhs. The unspent balance of Rs 39.98 Lakhs of the Grant released in the Year 2017-18 has been deducted from the fourth instalment of the grant for the year 2018-19 by ICSSR reducing the annual (2018-19) Grant of Rs 259.00 Lakhs release to 219.02 Lakhs
- 9. The Member Secretary, State Planning Commission in the reference 14<sup>th</sup> read above, has requested the Government to release the balance State Matching Grant of Rs.4.02 lakhs being the 4<sup>th</sup> installment of salary grant and General grant to Madras Institute of Development Studies for the financial year 2018-2019.
- 10. The total matching release to MIDS with the Rs.4.02 Lakhs requested will come to Rs 219.02 Lakhs which is the amount released by ICSSR for the year 2018-19. A sum of Rs.193.00 Lakh is available in the Budget Estimate of 2019-2020 for the release of Rs.4.02 Lakh.
- 11. The Government after careful consideration, accord sanction and release the State's matching share of Rs.4,02,000/- (Rupees Four Lakhs and Two thousand only) equal to the amount released by the Indian Council of Social Science Research , New Delhi in the 4<sup>th</sup> instalment to the Madras Institute of Development Studies towards grants in aid for the year 2018-2019.
- 12. The expenditure sanctioned in para-11 above shall be debited under the following head of account
