#### **ORDER:**

In the Government Orders first and second read above, orders were issued that the Government of Tamil Nadu would sanction matching grant equal to the amount sanctioned by the Indian Council of Social Science Research (ICSSR) to the Madras Institute of Development Studies, Chennai every year.

2. In the Government Order third read above, Government formulated certain procedure for sanction of matching grant to Madras Institute of Development Studies, Chennai instead of sanctioning block grant.

3. In the Government order Fourth read above, the Government had accorded sanction and released the State's matching share of a sum of 4.02 lakhs being the 4<sup>th</sup> installment of salary grant and General grant to Madras Institute of Development Studies for the financial year 2018-19, from the amount of Rs.193.00 lakhs provided in the Budget Estimate of 2019-2020.

4. The Indian Council of Social Science Research in its reference fifth read above, has sanctioned and released a sum of Rs.26.00 lakhs as ad-hoc grant to meet the salary expenses of 1<sup>st</sup> half of 1<sup>st</sup> quarter of the financial year 2019-2020 under Salary Grant (OH-36) as Ad-Hoc installment.

5. The Member Secretary, State Planning Commission in the reference seventh read above, has requested the Government to release the State Matching Grant of Rs.26.00 lakhs as Ad-hoc Grant to Madras Institute of Development Studies, Chennai for the year 2019-2020. A sum of Rs.188.98 lakhs is now available in the Budget Estimate 2019-2020 for the release of Rs.26.00 lakhs.

6. The Government after careful consideration, accord sanction and release of the State's matching share of Rs.26.00 lakhs (Rupees Twenty Six Lakhs only) equal to the amount released by the Indian Council of Social Science Research, New Delhi being the Ad-Hoc grant to meet the salary expenses of 1<sup>st</sup> half of 1<sup>st</sup> quarter of the financial year 2019-2020 to the Madras Institute of Development Studies towards grants in aid for the year 2019-20.

7. The expenditure sanctioned in para-6 above shall be debited under the following head of account
