- 2. In the reference second cited, on transfer of Tmt. P. Amudha, IAS., to Lal Bahadur Shastri National Academy of Administration (LBSNAA), Mussoorie, Dr. Chandramohan. B, I.A.S., has been nominated as State Level Nodal Officer for Ramanathapuram District.
- 3. Monitoring Officers are being appointed to each District of the State by Government in Public Department, to review / inspect major schemes and programmes in the Districts and provide necessary suggestions / solutions to the respective District Officials to sort out the bottlenecks and pave way for speedy implementation of the programmes. The Monitoring Officers are to visit the Districts allotted to them once in a month and ensure that their inspections and reviews in the districts are purposeful and result oriented.

- 4. Dr. Chandramohan. B, IAS., who has been appointed as State Nodal Officer for Ramanathapuram district under Aspirational Districts Programme is also the Monitoring Officer for Ramanathapuram District. Dr. Santhosh Babu I.A.S., who had been appointed as State Nodal Officer for Virudhunagar Aspirational District is the Monitoring Officer for Dharmapuri District and is hence to visit two Districts and Virudhunagar District has two officers coming for review-State Nodal Officer of Aspirational District and Monitoring Officer. In order to have effective review of the implementation of Aspirational Districts Programme, it is considered that Monitoring Officer of the District be nominated as the Nodal Officer for the Aspirational District.
- 5. Hence, the Government have decided to nominate Tmt. S. Madumathi, IAS., Secretary to Government, Social Welfare and Nutritious Meal Programme Department Monitoring Officer for Virudhunagar District as State Level Nodal Officer for Virudhunagar Aspirational District in place of Dr. Santhosh Babu, I.A.S., Principal Secretary to Government, Information Technology Department.
