2. From the Head of Division (Land Use) (FAC), State Planning Commission, Chennai-5, Letter No.1001/SPC/SADP/2017, Dated: 06.05.2019.

ORDER:

In the Government Order first read above, orders were issued for the formulation of a new scheme called Special Area Development Programme (SADP) with guidelines for administration and field implementation of the programme.

- 2. Based on the Orders issued in Government Order cited, the State Level Technical Cell for the Hill Areas of Tamil Nadu (STCHA) has been established in the State Planning Commission and function under the State Land Use Research Board. The administration and field implementation of the Special Area Development Programme has been taken up in two units. The Unit-1, the office of the Project Director, SADP, Udhagamandalam covers 4 districts viz., The Nilgiris, Coimbatore, Tiruppur and Erode. The Unit-2, SADP, the State Level Technical Cell at the State Planning Commission oversee the field implementation in the remaining districts of Western Ghats viz., Dindigul, Madurai, Theni, Virudhunagar, Tirunelveli and Kanniyakumari through the District Planning Cells in each of these districts.
- 3. In the letter second read above the Head of Division (Land Use) (FAC), State Planning Commission has stated that the Project Director, Udhagamandalam has submitted the proposal for allocation of 1% Monitoring Evaluation fund for Unit-1. Further, he proposed for allocation of 1% (75 Lakhs) within the allocated budget estimates Rs.75 crore for the works related to Evaluation, Monitoring and other administrative expenses in the ratio of 60:40 (Rs.45 lakhs & Rs.30 lakhs) to SADP Unit-1 and SADP Unit-2 respectively.
- 4. The Government after careful consideration, accept the proposal of the Head of Division (Land Use) (FAC), State Planning Commission and the Project Director, SADP, Udhagamandalam and accord sanction of 1% of Special Area Development Programme (SADP) allocation every year in the ratio of 60:40 for SADP Unit-1, to the office of Project Director, Special Area Development Programme, Udhagamandalam and for Special Area Development Programme Uni-2 to the office of State Level Technical Cell

at the State Planning Commission, Chennai respectively to meet out the expenditure related to Administration and Monitoring of Special Area Development Programme.

- 5. The Government also sanction an amount of Rs.45 lakhs (Rupees Forty Five Lakhs only) for Unit-1 SADP, Udhagamandalam and Rs.30 lakhs (Rupees Thirty Lakhs only) for Unit-2 to the office of State Level Technical Cell at the State Planning Commission, Chennai for the year 2019-2020 and the sanctioned amount shall be debited to the following head of account under Demand No.36 Planning Development and Special Initiatives Department.
- "2551 Hill Areas 01-Western Ghats 137-Special Area Devlopment Programme- State's Expenditure JA- Plan Formulation Cell -399 Miscellaneous 01-Miscellaneous (DPC 2551-01-137-JA-399-01)"
- 6. Necessary additional funds of Rs.75 lakhs will be provided in RE/FMA 2019-2020. Pending provision of such funds in RE/FMA 2019-2020 the Member Secretary, State Planning Commission is authorised to draw and disburse the amount sanctioned in paragraph 5 above. The Member Secretary, State Planning Commission should include the additional expenditure while sending the proposal to Government of inclusion of RE/FMA 2019-2020 without fail. However, this expenditure shall be brought to the notice of Legislature by Specific Inclusion(SI) in the Supplementary Estimates 2019-2020. The Member Secretary, State Planning Commission is directed to send necessary draft explanatory notes to Government in Finance(BG-1/Public) Department for inclusion of the Supplementary Estimates 2019-2020.
- 7. The Project Director, SADP, Udhagamandalam is directed to send expenditure details for the amount received so far to the Member Secretary, the State Planning Commission, Chennai-5.
- 8. This order issues with the concurrence of Finance Department vide its U.O.No.33893 / Fin(Pub)/19, dated: 24.10.2019 and Additional Sanction Ledger No.1885 (One thousand eight hundred and eighty five).
