### **ORDER:**

In the reference first read above, the Director Madras Institute of Development Studies has forwarded the proposal for Enhancing Research Capacity for Systematic and Scientific Sample Surveys for Understanding Socio-Economic Development in Tamil Nadu.

2. In the Government letter second read above the Principal Secretary/ Commissioner, Department of Economics and Statistics was instructed to take up the project of “Tamil Nadu House Hold panel Survey” under TANII and also requested to send necessary proposal to SPC for funding. Therefore, the State Planning Commission recommended the proposal for consideration under TANII for the year 2015-16 at a total cost of Rs.390.00 lakhs for a period of three years.

3. In reference G.O third read above, Order has been issued approving the project "Tamil Nadu Household Panel Survey (TNHPS)" with a total project cost of Rs.390.00 lakh for the period of three years under TANII and also released an amount of Rs.10.00 lakh for the year 2015-2016 (first year) for undertaking the preparatory work of the survey.

4. In the letter 4th read above, the Principal Secretary/Commissioner, Department of Economics and Statistics has forwarded the proposal for the second phase of the project, for the year (2016-2017) with a request to release an amount of Rs.250.00 Lakhs for the year 2016-2017, to carry out the training of field staff, procurement of Hardware (CAPI) (Rs.160.70 Lakh) and Software for data collection (Rs.89.30 Lakh).

5. The Government after careful consideration accord release a sum of Rs.250.00 lakhs (Rupees Two Crore and Fifty Lakhs only) as the second year cost in 2016-17 which is included in the total project cost of Rs.390.00 lakhs for undertaking the "Tamil Nadu House hold Panel Survey".

6. The expenditure sanctioned in Para 5 above shall be debited to the following head of account:-
