CHENNAI METRO RAIL PROJECT – PHASE-I Extension - Lands required on permanent basis by Chennai Metro Rail Limited for implementation of the project – Utilization of 1172 sq.m of land of Metropolitan Transport Corporation in Tiruvottiyur Bus Terminus, Tiruvallur District, Tiruvottiyur Taluk and Village, Ward H, Block No.1, T.S.No.28/1 for construction of Metro Station - Enter upon permission to Chennai Metro Rail Limited (CMRL) – Orders – Issue

ORDER:

The Phase-I Extension of the Chennai Metro Rail Project is being implemented by Chennai Metro Rail Limited at an estimated cost of Rs.3770 crores. The construction works relating to underground stretch from Washermenpet to Korukkupet have been started. It is expected that the contracts for the remaining elevated stretch, stations and depot will be finalized and the construction works will be taken up during 2016-17. The Managing Director, Chennai Metro Rail Limited in the reference second read above has sent the list of lands belonging to State Government departments / Boards / Greater Chennai Corporation required for the implementation of the Phase-I Extension of the Chennai Metro Rail Project.

2. The High Power Committee (HPC) constituted in the Government Order first read above, met under the Chairmanship of Chief Secretary on 24.2.2016, discussed the proposal of Chennai Metro Rail Limited for transfer of lands of State Government departments / Boards / Corporation of Chennai on permanent basis with the Secretaries / Heads of Departments / Chief Executive Officers of the boards / organizations concerned in detail. The High Power Committee, after detailed

discussions has made recommendations on each of the land transfer proposals of Chennai Metro Rail Limited to Government. 1172 sq.m of Metro Transport Corporation land in Tiruvottiyur Bus Terminus is one of the land recommended by HPC for according enter upon permission to Chennai Metro Rail Limited for implementation of Phase-I Extension of Chennai Metro Rail Project, pending finalization of modalities of utilization of the land by Metro Transport Corporation and Chennai Metro Rail Limited for construction of Tiruvottiyur Bus Terminus and Metro Station respectively.

3. The Government after careful consideration accept the recommendation of the High Power Committee and accord enter upon permission to Chennai Metro Rail Limited in respect of the land to the extent of 1172 sq.m in Tiruvottiyur Bus Terminus, Tiruvallur District, Tiruvottiyur Taluk and Village, Ward H, Block No.1, T.S.No.28/1 belonging to Metropolitan Transport Corporation. The extent of requirement of land indicated above is tentative, which will be finalized separately by Chennai Metro Rail Limited at the time of finalizing the alignment of corridor and design of the metro stations etc.

4. Since the proposal for construction of metro station in the said land has already been recommended by High Power Committee and approved by the Government, the Transport Department shall issue the orders on modalities of utilization of the land by Metro Transport Corporation and Chennai Metro Rail Limited for construction of Tiruvottiyur Bus Terminus and Metro Station respectively.

5 This order is deemed to have been issued with the concurrence of the Secretariat departments concerned with reference to the delegation of powers to the High Power Committee constituted in the Government Order first read above.
