In the letter read above, the Project Director, Special Area Development Programme- Unit-I, Udhagamandalam has proposed for utilizing an amount of Rs.38.00 lakhs from out of the Savings and Interest funds of erstwhile Hill Area Development Programme as the State's Share in establishing of "One Stop Centre" at District Head Quarters Hospital, Udhagamandalam. The project has been sanctioned by guideline of the Ministry of Women and Child Development (MWCD) at a total cost of Rs.86.00 lakhs, for which, the Government of India has allocated a sum of Rs.48.00 lakhs.

- 2. The Government after consideration accept the proposal of the Project Director, Special Area Development Programme, Unit-I, Udhagamandalam to utilize an amount of Rs.38.00 lakhs (Rupees Thirty Eight Lakhs only) from the Savings and Interest funds of erstwhile Hill Area Development Programme.

The Collector of The Nilgiris District is authorized to disburse the amount of Rs.38.00 lakhs (Rupees Thirty eight lakhs only) to the District Social Welfare Officer, Nilgiris district from the savings amount available under Hill Area Development Programme funds over the years. The Project Director, SADP-I, Udhagamandalam should maintain the accounts as per existing procedure prescribed by the Government in force.

The Collector of The Nilgiris District is requested to ensure that detailed estimates with the Detailed Project Report is available and photographic evidence is obtained with the report (wherever relevant) definitely after completion of the work. The completion report should indicate the fact of actual use and user benefits

realized with photographic evidence. The Public Works Department is also requested to ensure the type design of the proposed building adapting to the hilly conditions with experts consultation / technical supervision and ensure greenery around the building within the estimated cost.

The Implementing agencies are requested to implement the work effectively in consultation with the District Collector / The Project Director, Special Area Development Programme, Unit-I, Udhagamandalam and to send a report for the completion of works to the Government through the Project Director, Special Area Development Programme- Unit-I, and District Collector.
