### ORDER:

In the Government Order first read above, orders have been issued for the implementation of New Health Insurance Scheme,2016 to provide health care assistance to the Employees of Government Departments, Organisations covered under this Scheme and their eligible Family members with a provision to avail assistance up to the limit of Rs.4.00 lakh in a block period of four years from 01.07.2016 as a Cashless model for the approved treatments/surgeries (listed in the Annexure to the said order) in the network hospitals approved through the United India Insurance Company Limited, Chennai.

- 2. In the Government Order second read above, orders have been issued for the extension of the New Health Insurance Scheme, 2016 for a period of another one year from 01.07.2020 to 30.06.2021.
- 3. In letter third read above, the Director, Madras Institute of Development Studies, had requested the Government to include the 15 academic faculty members in the cadre of Professors, Associate Professor and Assistant Professor and 25 non academic staff members, to join them in the New Health Insurance Scheme 2016 and had agreed to undertake to pay the necessary employer and employee contributions as per the Government Order first read above and adhere to the rules and regulations of the said scheme.

- 4. The Government after careful consideration accept the request of the Director, Madras Institute of Development Studies and extend the coverage of New Health Insurance Scheme 2016 to the regular Official and Staff members (around 15 academic faculty members and 25 non-academic staff members) of the Madras Institute of Development Studies, Chennai 600 020 as per the terms and conditions of the scheme.
- 5. The period of coverage will be for a period commencing from the date of issue of Government Order till 30.06.2021.
- 6. The Director, Madras Institute of Development Studies shall make necessary arrangements to remit the premium payable as per the scheme guidelines within one month from the date of issue of Government order under the Revenue Receipt Head of Account.
