#### **ORDER:**

In the reference first read above, the Government issued orders for institutionalize an evidence-based approach to policy making to maximize the impact of anti-poverty programmes and policies in the state partnership with Abdul Latif Jameel-Poverty Action Lab (J-PAL), and constituted the Steering Committee to approve the new pilot programmes and evaluation.

2. The Second Steering Committee meeting was convened on 28.07.2015 under the Chairmanship of the Principal Secretary to Government, Finance Department. The proposal for Urban Unemployment of Evaluating Skill and Matching Constraints has been included in the agenda for approval. Dr. Gharad Bryan presented a proposal looking to address the problem of high urban unemployment and underemployment along with co-researchers, Dr.Mushfiq Mobarak (Yale University) and Dr. Melanie Morton (Stanford University). The Policy — research proposal is aimed at doing a randomized evaluation to determine the impact of the training programme under

the Tamil Nadu Urban Livelihood Mission (TNULM) on employment outcomes and the impact of subsides to incentivize firms to employ certain types of workers. The project is (focused on understanding ways to generate high quality matches between workers and employer) The project is expected to start in October 2015 and end in March 2017.

The Steering Committee after a careful consideration of the detailed agenda note and a presentation by the investigators has approved the above proposal. The total project cost for the first and second year are Rs.2,26,99,125/-. The component wise expected cost shared by J-PAL and the Government of Tamil Nadu are tabulated below:-

- 3. Based on the approval of the Second Steering Committee, Government after careful consideration, approve the total project cost of Rs.2,42,59,125/- and accord sanction for a sum of Rs.2,26,99,125/- (Rupees Two crores twenty six lakhs ninety nine thousand one hundred and twenty five only) towards the share of Government of Tamil Nadu for Urban Unemployment Evaluating Skill and Matching Constraints. The roles and responsibilities of the Department and J-PAL are indicated in the annexure to the Government Order.
- 4. The expenditure on State's share sanctioned in para 3 above shall be met from the 5 percent fund allocated under State Innovation Fund intended for evaluation and capacity building and shall be debited under the following head of account:

The Member Secretary, State Planning Commission is also requested to send necessary explanatory notes to Finance (Public) Department for inclusion in the Supplementary Estimates 2015-16.

# **ROLES AND RESPONSIBILITIES**

#### J-PAL South Asia

- 1. Design study protocols (with support and input from the government) for activities being undertaken as part of the research study.
- 2. Hold consultations with the Directorate of Municipal Administration (DMA) to fianlise study design (research sites and incentive structure).
- 3. Hire and train project staff (Research Associate, Project Associate, surveyors and monitors) to oversee the research evaluation.
- 4. Establish a field office to act as a base for all research activities.
- 5. Conduct surveys and collect data (through a baseline, midline and end line).
- 6. Monitor the study implementation, create monitoring plans, checklists, prepare reports for the government, etc.
- 7. Coordinate meetings with the relevant government departments at different project stages on the progress of the evaluation and submit reports / presentations.
- 8. Analyse data and prepare a final evaluation results.
- 9. Disseminate evaluation findings to the relevant stakeholders along with the Government.

## Department of Municipal Administration and Water Supply

- 1. Nominate a nodal officer from DMA or and Tamil Nadu Urban Livelihoods Mission to lead discussions with the research team and provide guidance on the Government expectations and evaluation design.
- 2. Guide the research team on getting the necessary approvals and documentation required to set up the evaluation.
- 3. Provide assistance with introduction to job fairs, and prospective employer pool registered with TNULM.
- 4. Grant timely approvals to implement the study.
- 5. Ensure adherence to research requirements as listed by J-PAL.
