ORDER:

In the Government Order first read above, orders have been issued renaming the Planning and Development Department as Planning Development and Special Initiatives Department so as to pursue special initiative projects in consultation with the respective administrative departments of the Secretariat. Consequently in the Government order second read above the Business Rules have been amended by renaming the Planning & Development Department as Planning, Development and Special Initiatives Department.

2. The proposal for inclusion of subjects relating to Special Initiatives in the Business Rules has been examined. After careful consideration, it has been decided that "Special Initiatives" as a subject is distinct from any particular initiative which may materialize at some point of time. A Particular matter may be a "Special Initiative" at one stage and later may become a normal subject assigned to a specific department. Special Initiatives may cover concurrent or State subjects. It has therefore been decided to include the subject "Special Initiatives" in the Business Rules under 'Concurrent Subjects'.

3. The Government accordingly direct that the subject "Special Initiatives" be included in the First Schedule of the Business Rules under "Concurrent Subjects".

4. Necessary amendment to the Tamil Nadu Government Business Rules will be issued in Personnel and Administrative Reforms (A) Department separately.
