#### **ORDER:**

In the Government Order first read above, Government has accorded administrative sanction for Rs.1603.62 lakhs towards construction of Regional Director/Assistant Director/Divisional Statistical Officer offices under India Statistical Strengthening Project (ISSP).

- 2. The Chief Engineer, Public Works Department, in his letter second and third read above, has informed that the Revised Administrative Sanction proposal for the construction work for District Deputy Director office in Ramanathapuram District at a cost of Rs.55,96711/- (Administrative Sanction Rs.50,66,000/-) with an excess amount of Rs.5,30,711/- and Construction of Regional and District Statistics Office in Tirunelveli District at a cost of Rs.1,01,75,000/-(Administrative Sanction Rs.89,30,000/-) with an excess amount of Rs.12,45,000/- placed before the Tender Award Committee. He has also stated that Tender Award Committee has accepted this Revised Administrative Sanction for Rs. 55,96711/- and Rs.1,01,75,000/-, with an instruction that there should not be any further Revised Administrative Sanction and requested approval for this Revised Administrative Sanction.
- 3. The Principal Secretary/Commissioner, Department of Economics and Statistics, has therefore, requested the Government to issue revised administrative sanction orders for Rs.55,96,711/- (original Sanction amount Rs.50,66,000/- + requirement of excess amount Rs. 5,30,711/- and Rs. 1,01,75,000/- (original Sanction

amount Rs. 89,30,000/- + requirement of excess amount Rs. 12,45,000/- for construction of District Deputy Director office in Ramanathapuram and Regional and District Statistics Office in Tirunelveli District respectively.

- 4. The Government after careful consideration of the proposal of the Principal Secretary/Commissioner, Department of Economics and Statistics, accord revised administrative sanction for Rs.55,96711/-(Rupees Fifty five lakhs ninety six thousand seven hundred and eleven only) towards Construction of District Deputy Director office in Ramanathapuram and Rs. 1,01,75,000/-(Rupees One Crore one lakh and seventy five thousand only) towards construction of Regional and District Statistics Office in Tirunelveli District under ISSP. The net additional commitment involved consequent to aforesaid Revised Administrative Sanction is Rs.17,75,711/- (Rupees Seventeen Lakh Seventy Five Thousand Seven Hundred and Eleven only)
  - 5. The additional expenditure shall be debited under the head of account:-

"5475 00 Capital Outlay on Other General Economic Services – 112. Statistics Schemes in the Eleventh Five Year Plan – III.Centrally Sponsored- SA Implementation of Tamil Nadu State Strategic Statistical Plan(TNSSSP) 16 Major works" (DPC 5475 00 112 SA 1609)

- 6. Necessary additional funds will be provided in Final Modified Appropriation 2015-16. Pending Provision of funds in Final Modified Appropriation 2015-16, the Principal Secretary/Commissioner, Department of Economics and Statistics is authorized to incur the amount. The Principal Secretary/Commissioner, Department of Economics and Statistics should include the amount sanctioned in para-4, above while sending budget proposal for Final Modified Appropriation 2015-16 to Finance (Public) Department.
