ORDER:

Monitoring Officers are being appointed to each District of the State by Government in Public Department, to review / inspect major schemes and programmes in the Districts and provide necessary suggestions / solutions to the respective District Officials to sort out the bottlenecks and pave way for speedy implementation of the programmes. The Monitoring Officers are to visit the Districts allotted to them once in a month and ensure that their inspections and reviews in the districts are purposeful and result oriented.
- 4. Consequent on the above, being Monitoring officers for the respective districts, Dr.B.Chandramohan, IAS., and Tmt. S. Madumathi, IAS., were nominated as State Level Nodal Officers for Ramanathapuram and Virudhunagar Aspirational Districts respectively vide orders second and third read above.
- 5. In the Government order fourth read above, Thiru. Dharmendra Pratap Yadav, IAS., Principal Secretary to Government, Transport Department being Monitoring Officer for Ramanathapuram was appointed as State Level Nodal Officer for Ramanathapuram District in the place of Dr. B.Chandramohan, IAS.,
