### ORDER:

The announcement was made in the Governor's Address delivered to the Tamil Nadu Legislative Assembly on 21.6.2021 as follows:

"Feasibility studies for Mass Rapid Transit Systems for Madurai, Tiruchirappalli, Salem and Tirunelveli will be taken up"

2. Based on the above announcement, the Managing Director, CMRL has submitted a proposal requesting the Government to issue necessary orders, permitting CMRL to prepare the "Feasibility Study Report (FSR) for a Mass Rapid Transit System for Madurai, Salem, Tiruchirapalli and Tirunelveli" with an estimated outlay of Rs.2.80 crore (excluding GST) in the reference cited.

3. The Government, after careful examination, have accepted the proposal of the Managing Director, Chennai Metro Rail Limited (CMRL) and permit CMRL to pursue the preparation of "Feasibility Study Report (FSR) for establishing a Mass Rapid Transit System (MRTS) for Madurai, Salem, Tiruchirapalli and Tirunelveli" with an estimated outlay of Rs.2.80 crore (excluding GST).

4. The Government also accord permission to entrust the preparation of Feasibility Study Report (FSR) mentioned in para 3 above with the Chennai Metro Rail Limited. The cost of preparation of FSR will be met from the Project Preparation Fund of Tamil Nadu Infrastructure Development Board (TNIDB).

5. The Government also advices the concerned Corporations to provide all support and information towards timely and accurately completing this task. The Managing Director, Chennai Metro Rail Limited shall send a detailed report to Government on the progress of preparation of "Feasibility Study Report (FSR) for Madurai, Salem, Tiruchirapalli and Tirunelveli" on a monthly basis.
