#### **ORDER:**

In the Government Orders second, third and fourth read above, orders have been issued according administrative sanctions for acquisition of the total extent of 117.12.37 hectares of private patta lands and 59.81.17 hectares of Government lands in Chennai, Chengalpattu, Kancheepuram and Thiruvallur Districts for implementation of Phase-II of Chennai Metro Rail Project covering a total length of 118.9 km under the provisions of the Tamil Nadu Acquisition of Land for Industrial Purposes Act, 1997 (Act 10 of 1999).

2. In the Government Order fifth read above, orders have been issued appointing the District Revenue Officer or the Special District Revenue Officer (Land Acquisition) [DRO(LA)], as the case may be, of the district concerned to perform the functions of the Collectorunder Clause (a) of Section 2 of the Tamil Nadu Acquisition of Land for Industrial Purposes Act, 1997 (Tamil Nadu Act 10 of 1999).

- 3. In the Notification issued with the Government Order first read above, it has been directed that all the powers exercisable by the Government under the said Act except the powers excluded in Section 23-A shall be exercised by the "Collector" of the district concerned.
- 4. Based on the proposal of Chennai Metro Rail Limited in the reference sixth read above, the Commissioner of Land Administration, in his reference seventh read above, has requested the Government to issue necessary orders to designate the "Special DRO (LA), Chennai Airport Expansion Scheme" to perform the functions of the "Collector" under the Tamil Nadu Acquisition of Land for Industrial Purposed Act, 1997 in order to carry out the land acquisition works for Chennai Metro Rail Projects in the Districts of Chennai, Chengalpattu, Kancheepuram and Thiruvallur.
- 5. The Government, after careful consideration of the proposals of the Commissioner of Land Administration, accords administrative approval to designate the Special DRO (LA), Chennai Airport Expansion Scheme to perform the functions of the "Collector" under the Tamil Nadu Acquisition of Land for Industrial Purposes Act, 1997 to carry out the land acquisition works for Chennai Metro Rail Projects in the Districts of Chennai, Chengalpattu, Kancheepuram and Thiruvallur.
