In the Government Orders first and second read above, the Government of Tamil Nadu have agreed to sanction matching grant equal to the amount sanctioned by the Indian Council of Social Science Research (ICSSR) to the Madras Institute of Development Studies(MIDS), Chennai every year.

The Indian Council of Social Science Research, in its letter fourth read above, has accorded its sanction for a amount of Rs.40.00 lakhs being the annual recurring development plan grant to Madras Institute of Development Studies, Chennai for the year 2015-2016 and the ICSSR in the letter fifth read above has accorded sanction for a amount of Rs 200.00 lakhs towards annual Maintenance Non-Plan recurring Salary Grant to Madras Institute of Development Studies, Chennai for the year 2015-2016.

3. In the Government Order sixth read above, an amount of Rs.49.00 lakhs was released to the Madras Institute of Development Studies, Chennai as the Plan and Non Plan matching grant for the year 2015-16 equal to the amount released by the ICSSR, New Delhi.

The ICSSR in its letter seventh and eight read above has released an amount of Rs.71.00 lakhs being the 2nd installment of the Non-Plan recurring Grant and an amount of Rs.60.00 lakhs(Rs.10.00 lakhs Plan + Rs.50.lakhs Non Plan) being the 3rd installment of the Plan- Non-Plan recurring Grant to Madras Institute of Development Studies, Chennai for the year 2015 -2016 as detailed below. The Member Secretary, State Planning Commission in his letter ninth read above, has requested the Government to release the State's share of second and third installment of Plan - Non-Plan recurring grant to Madras Institute of Development Studies, on matching basis, for the year 2015-2016.

The Government after careful consideration, accord to sanction for release of a sum of Rs.131.00 lakhs (Rupees One Hundred and Thirty One lakhs only) equal to the amount released by the ICSSR, New Delhi as State's matching grant to the Madras Institute of Development Studies, Chennai, for the year 2015-2016, as detailed at para 4 above.

6. The expenditure sanctioned in Para.4 above shall be debited under the head of account "3475 00 Other General Economic Services – 800 Other Expenditure Non-Plan – AI Grants to Madras Institute of Development Studies -09 Grants in aid- 01.Grants for Current Expenditure" (DPC 3475 00 800 AI 0910).

7. Necessary additional fund of Rs 33.00 lakhs will be provided in Final Modified Appropriation, 2015-2016. Pending provision of such funds in FMA, 2015-2016, the Member-Secretary, State Planning Commission is authorized to incur the expenditure sanctioned in para 5 above. This expenditure shall be brought to the notice of the Legislature by specific inclusion in the Supplementary Estimates, 2015-2016. The Member-Secretary, State Planning Commission is also requested to send necessary explanatory notes for including the expenditure in the Supplementary Estimates, 2015-2016 and also include this expenditure, while sending budget proposals for Final Modified Appropriation to Government in Finance (Public) Department without fail.
