ORDER:

Letter second read above, the Vice Chairman, State Planning Commission has proposed creation of one Additional Full Time Member post on a temporary basis till end of the present State Planning Commission and nominated Professor M.Vijaya Baskar now Part Time Member of the reconstituted State Planning Commission for appointment as Additional Full Time Member of the State Planning Commission.

After careful examination Government accord sanction of an additional Full Time Member post in the State Planning Commission on a temporary basis and appoint Prof. M.Vijaya Baskar now Part Time Member as additional Full Time Member in the State Planning Commission with effect from date of assumption of charge.
