ORDER:

Government of India in his letter first read above have conveyed their Administrative approval and allotted an amount of Rs.37,92,89,000/- to Government of Tamil Nadu for conduct of 6th Economic Census and released a sum of Rs.60.08 lakh to carry out the preliminary work for the commencement of the census. In Government Order second read above, Government accorded sanction for a sum of Rs.60,08,000/- for the year 2012-13 towards the expenditure on salaries, printing, advertisement, training and publicity and orders issued for creation of posts. In Government Order third read above, Government sanctioned an advance of Rs.57,58,800/- towards conduct of 6th Economic Census towards the expenditure of Printing, Advertisement, Training and publicity for the year 2012-2013.

2. In the Government Order fourth read above, Government sanctioned an amount of Rs.28,39,08,000/- towards conduct of the 6th Economic Census during the year 2013-14. In the Government Order fifth read above, Government have released an amount of Rs.27,94,74,613/- which was unspent during the financial year 2013-2014 to meet the committed expenditure in the current financial year.

3. In the letter fifth read above, Government of India have released an amount of Rs. 8,52,97,611/- (Rupees Eight crore fifty two lakh ninety seven thousand six hundred and eleven only) for the purpose of payment of honorarium and TA/DA to enumerators, supervisors, Contingencies etc.,. The Principal Secretary/ Commissioner, Department of Economics and Statistics, has therefore requested the Government to issue order for Rs. 8,52,97,611/- for 2014-15 towards conduct of 6th Economic Census.

4. The Government after careful consideration, accept the proposal of the Principal Secretary/Commissioner, Department of Economics and Statistics and, accord sanction for release of an amount of Rs.8,52,97,611/- (Rupees Eight crore fifty two lakh ninety seven thousand six hundred and eleven only) towards conduct of 6th Economic Census during the year 2014-2015.

5. The expenditure sanctioned at para 4 above shall be debited under the head of account:-

The Principal Secretary/Commissioner, Department of Economics and Statistics is also requested to send necessary explanatory notes to Finance(BG-I/Public) Department for inclusion of Supplementary Estimates 2014-2015.
