### ORDER:-

In the Government Orders first and second read above, the Government of Tamil Nadu have agreed to sanction matching grant equal to the amount sanctioned by the Indian Council of Social Science Research (ICSSR) to the Madras Institute of Development Studies, Chennai every year. The Indian Council of Social Science Research, in its letter fourth read above, has accorded its sanction for a amount of

Rs.40.00 lakhs being the annual recurring development plan grant to MIDS Chennai for the year 2015-2016 and the ICSSR in its letter fifth read above has accorded its sanction for a amount of Rs 200.00 lakhs being the annual recurring maintenance and development Non plan Grant to MIDS Chennai for the year 2015-2016.

The ICSSR in its letter sixth to eighth read above has released an amount of Rs.49.00 lakhs Plan and Non-Plan(Recurring) as detailed below and the MS, SPC in his letter ninth read above, has requested the Government to release the State's share of Plan and Non-Plan recurring grant to Madras Institute of Development Studies, on matching basis, for the year 2015-2016.

The Government after careful consideration, accord to release for a sum of Rs.49.00 lakhs (Rupees Fourty Nine lakhs only) equal to the amount released by the ICSSR, New Delhi as State's matching grant to the Madras Institute of Development Studies, Chennai, for the year 2015-2016, as detailed at para 2 above.

The expenditure sanctioned in Para.3 above shall be debited to under the head of account "3475 00 Other General Economic Services 800 Other Expenditure 1- Non-Plan Al Grants to Madras Institute of Development Studies -09 Grants in aid- 01.Grants for Current Expenditure" (DPC 3475 00 800 Al 0910).
- 5. The Member-Secretary, State Planning Commission is requested to draw and disburse the amount sanctioned in para 3 above to the MIDS, Chennai under proper acknowledgement and watch the receipt of the utilization certificate from the above institute.
