ORDER:

Consequent on the formation of New Bus Terminal at Kilambakkam, near Vandalur, the necessity has arisen to extend the metro rail from Airport to Kilambakkam. The section from Tambaram to Velachery has also become a potential corridor with a Peak Hour Peak Direction Traffic (PHPDT) of around 10,000 as per the Comprehensive Mobility Plan (CMP) for Chennai Metropolitan Area. The Government has therefore decided to prepare the DFR / DPR for the Metro Rail extension and new rail based project.

- 2. The Government accordingly accord approval for the preparation of DFR /DPR for implementation of the following rail based project and extension of metro rail:
 - I. Light Rail Connectivity from Tambaram to Velachery.
 - II. Extension of Phase-I of Metro Rail from Airport to Kilambakkam Bus Terminal.

- 3. The Government also accord permission to entrust the preparation of DFR /DPR mentioned in para 2 above with the Chennai Metro Rail Limited. The cost of preparation of DFR /DPR will be met from the Project Preparation Fund of Tamil Nadu Infrastructure Development Board (TNIDB).
- 4. The Managing Director, Chennai Metro Rail Limited shall send a detailed report to Government on the progress of preparation of DFR / DPR on monthly basis.
