ORDER:

The High Power Committee (HPC) in the 17th meeting held on 09.10.2017 has approved the proposal of transferring the additional lands belonging to Greater Chennai Corporation required in T.S.No.43/5 and 42, Block No.7, Vepery Village, Purasaivakkam Taluk, Chennai District and measuring 458.60 sq.m. on permanent basis for development of the area as Central Square, the multi modal integration project and recommended to Government for issue of necessary Government Orders for immediate enter upon permission and separately for transfer.

- 2. In the letter fourth read above Managing Director, Chennai Metro Rail Limited, Chennai has sent a proposal to Government for issuing Administrative Sanction for transfer of lands belonging to Greater Chennai Corporation required in T.S.No.43/5 and 42, Block No.7, Vepery Village, Purasaivakkam Taluk, Chennai District and measuring 458.60 sq.m. on permanent basis for development of the area as Central Square for the purpose of the multi modal integration project and also to issue enter upon permission to Chennai Metro Rail Limited to the enter the above Land.
- 3. The Government after careful consideration accepts the recommendation of the High Power Committee and proposal of Managing Director, Chennai Metro Rail Limited and accords Administrative Sanction for the transfer of additional lands belonging to Greater Chennai Corporation in T.S.No.43/5 and 42, Block No.7, Vepery Village, Purasaivakkam Taluk, Chennai District measuring 458.60 sq.m. on permanent basis to the Chennai Metro Rail Project and permits Chennai Metro Rail Limited to enter upon the above land with immediate effect in view of the urgency involved in the implementation of the Project, pending issue of alienation orders. The extent of requirement of land indicated above is tentative, which will be finalized by Chennai Metro Rail Limited at the time of finalizing the alignment of corridor and design of the metro stations etc.
- 4. The Commissioner of Greater Chennai Corporation, Chennai shall send a necessary alienation proposal to Government in Municipal Administration and Water Supply Department by following the guidelines issued in the Government letter second read above to transfer the above land in favour of Chennai Metro Rail Limited on permanent basis.
- 5. This order is deemed to have been issued with the concurrence of the Secretariat Departments concerned as this order is made based on decisions of the High Power Committee constituted in the Government Order first read above.
