ORDER:

In the Government Order and letter first and second read above, orders have been issued according administrative sanction for undertaking DFR/DPR study for implementation of three Metro Rail Corridors in Chennai Metropolitan Area under Phase-II of Chennai Metro Rail Project. M/s RITES Ltd, who has been engaged for preparation of DPR, has submitted the report to Government. The DPR was scrutinized by the High Power Committee chaired by the Chief Secretary to Government in its 16th meeting held on 08.03.2017.

- 2. The High Power Committee recommended approval for implementation of three metro rail corridors at a total length of 107.55 kms at an estimated completion cost of Rs.85,047 crore including land and taxes and excluding interest during construction.
 - 3. The Government after careful consideration, issue the following orders:
 - i. The Government approves in principle the following three Metro Rail corridors under Phase II of Chennai Metro Rail Project as per the Detailed Project Report (DPR) prepared by M/s RITES Ltd:-
