2) The Standing Finance Committee has approved the scheme of Implementation of Formation of Analytical and Publication Unit TANII Scheme as recommended by the State Planning Commission at a cost of Rs.28.30 lakhs under Tamil Nadu Innovation Initiatives (TANII) Schemes for the year 2016-2017 and 2017-2018.

In the reference third cited, the Principal Secretary/ Commissioner, Department of Economics and Statistics has requested the Government to incur the expenditure Rs.6,20,000 as maintenance fund for the Purchase of colour toner, Salary for DTP Expert and purchase of stationary for Publication Unit like Paper, Binding materials etc.,
