ORDER :-

In the Government Orders first and second read above, the Government of Tamil Nadu have agreed to sanction matching grant equal to the amount sanctioned by the Indian Council of Social Science Research (ICSSR) to the Madras Institute of Development Studies, Chennai every year.

- 2. The Indian Council of Social Science Research, in its letter fourth read above, has accorded its sanction for a amount of Rs.40.00 lakhs being the annual recurring development plan grant to MIDS Chennai for the year 2014-2015 and the ICSSR in its letter fifth read above has accorded its sanction for a amount of Rs.173.00 lakhs being the annual recurring maintenance and development Non plan Grant to MIDS Chennai for the year 2014-2015.
- 3. In the Government Order sixth read above, Government has sanctioned an amount of Rs.37.00 lakhs i.e. (the fourth installment of Rs.36.00 lakhs Non-Plan Grant and the balance amount on third installment of Rs.1.00 lakhs Non Plan Grant) was released to the Madras Institute of Development Studies, Chennai for the year 2013-2014 equal to the amount released by the ICSSR, New Delhi. In the Government Order seventh read above, an amount of Rs.117.00 lakhs was released to the Madras Institute of Development Studies, Chennai as the Plan and Non Plan matching grant for the year 2014-2015 equal to the amount released by the ICSSR, New Delhi.
- 4. The ICSSR in its letter eigth and ninth read above has released an amount of Rs.53.00 lakhs being the 3rd installment of the Non Plan and fourth installment of Plan (Recurring) as detailed below and the MS, SPC in his letter tenth read above, has requested the Government to release the State's share of third installment of Non-Plan recurring Grant and fourth installment Plan recurring Grant to Madras Institute of Development Studies, on matching basis, for the year 2014-2015.

- 5. The Government after careful consideration, accord sanction for release of a sum of Rs.53.00 lakhs (Rupees Fifty three lakhs only) equal to the amount released by the ICSSR, New Delhi as the third installment of Non- Plan recurring Grant and fourth installment Plan recurring Grant to Madras Institute of Development Studies, on matching basis, for the year 2014-2015 as detailed at para 4 above.
- 6. The expenditure sanctioned in Para 5 above shall be debited under the head of account:

"3475 00 Other General Economic Services – 800 Other Expenditure I Non-Plan – AI Grants to Madras Institute of Development Studies – 09 Grants in aid- 01 Grants for Current Expenditure" (DPC 3475 00 800 AI 0910).

- 7. Necessary additional funds of Rs.14.00 lakhs will be provided in FMA, 2014-2015. Pending provision of such funds in FMA 2014-2015, the Member-Secretary, State Planning Commission is authorized to draw and disburse the amount sanctioned in para.5 above to the MIDS, Chennai, under proper acknowledgement and watch the receipt of the utilization certificate from the above institute. This expenditure shall be brought to the notice of the legislature by specific inclusion in the Supplementary Estimates 2014-2015. The Member-Secretary, State Planning Commission is also requested to send necessary explanatory notes for including the expenditure in the Supplementary Estimates 2014-2015 and budget proposals including this expenditure while sending budget proposals for FMA 2014-2015 to Government in Finance (Public/BG-I) Department without fail.
