ORDER:

In the Government Order first read above, Government accorded sanction for a sum of Rs. 31.00 crores towards the Improvement of Statistical System in the State to be implemented during the period 2011-12 to 2014-15 with the assistance under 13th Finance commission. In the Government Order second read above, in partial modifications of the orders issued in the Government Order first read above, sanction is accorded for a sum of Rs.29.97 crores towards the Improvement of Statistical System in the State to be implemented during the period 2012-13 to 2014-15 with the assistance under 13th Finance commission.

2. In the reference third read above, Government have issued orders for administrative sanction of Rs.1816.41 [Rs.1640.21 lakhs (as per the orders issued in the reference second cited) + Rs.176.20 lakhs (unspent released for the year 2012-13)] for the year 2013-14 and also accorded administrative sanction for Rs.2547.775 lakhs for the year 2014-15, as per the orders issued in the reference second cited. Out of the amount already sanctioned in the reference fourth cited, Rs.5.81 crores has allotted for Web Portal and others under the component of Network Connectivity for the year 2014-15.

3. In the reference sixth read above, Government have approved the Detailed Project Report (DPR) prepared by Tamil Nadu e-Governance Agency including "Creation of Geographical Information System (GIS)" and application of Global Positioning Remote Sensing (GPRS). As per the approved DPR, the total project cost is Rs.14.47 crores.

4. The Principal Secretary/Commissioner, Department of Economics and Statistics, has requested to give necessary permission to release the full project cost of Rs.14.47 crores to implement the project of launching of Net Work Connectivity through ELCOT.

5. Government after careful consideration, accept the proposal of the Principal Secretary/Commissioner, Department of Economics and Statistics and sanction a sum of Rs.5.81 crores (Rupees five crores and eighty one lakhs only) to implement the project of launching of Network Connectivity through ELCOT under 13th Finance Commission grants anticipating the release of 3rd instalment grant by Government of India.

6. The expenditure shall be debited under the following head of account:-
