Indian Council of Social Science Research (ICSSR) to the Madras Institute of Development Studies(MIDS), Chennai every year. In G.O.Ms.No.69, PD&SI (SPC) Dept, Dated: 10.08.2016 an amount of Rs.41.50 Lakhs was released to the Madras Institute of Development Studies, Chennai as the Plan Development Grant and Non-Plan Salary Grant for the financial year 2016-2017 equal to the amount released by the ICSSR, New Delhi.

2. The Indian Council of Social Science Research in its letters fifth to sixth read above has released an amount of Rs.90.50 lakhs as detailed below towards the second installment of the Plan Development Grant along with SC&ST Component grant and Non-Plan Salary Grant for the financial year 2016-17.
