ORDER:

In the Government Orders first and second read above, the Government of Tamil Nadu have agreed to sanction matching grant equal to the amount sanctioned by the Indian Council of Social Science Research (ICSSR) to the Madras Institute of Development Studies (MIDS), Chennai every year.

In the Government Order Fourth, Fifth and Sixth read above an amount of Rs 41.50 lakhs, Rs.90.50 lakhs and 59.25 lakhs was released to the Madras Institute of Development Studies, Chennai as the Plan Development Grant and Non-Plan Salary Grant for the financial year 2016-2017 equal to the amount released by the ICSSR, New Delhi.

The Indian Council of Social Science Research in its letters seventh and eight read above has released an amount of Rs.80.50 lakhs (Rs.11.50 Lakhs Plan Development grant +Rs.4.50 lakhs One time Additional Plan Grant for the purchase of Intranet server, computers, IT equipments and accessories along with Rs.10.00 lakhs for SC & ST Component grant and Non-Plan salary grant Rs.54.50 Lakhs) being the fourth installment of the Plan and Non-Plan recurring Grant to the Madras Institute of Development Studies, Chennai, for the year 2016–2017 detailed below:-
