# **ORDER**

The State Planning Commission has recommended the proposal of implementing the E-evaluation System in the department at a total cost of Rs.62.46 lakhs under Tamil Nadu Innovation Initiatives (TANII) Schemes for the year 2016-2017, 2017-2018 and 2018-2019.

- 2) The Standing Finance Committee has approved the proposal for Implementation of the E-evaluation System in the department as recommended by the State Planning Commission at a cost of Rs. 62.46 lakhs under Tamil Nadu Innovation Initiatives (TANII) Schemes for the year 2016-2017, 2017-2018 and 2018-2019.
- 3) In the reference 3<sup>rd</sup> cited, the Director (FAC), Evaluation and Applied Research Department has proposed to sanction a sum of Rs.10,80,000/- for the second year 2017-18 under various components for the E-evaluation System.
- 4) The Government accordingly sanction a sum of Rs.10,80,000/-(Rupees Ten Lakhs Eighty thousand only) for Implementation of E-evaluation System under Tamil Nadu Innovation Initiatives (TANII) for the second year 2017-18.

5. The expenditure sanctioned in Para 4 above shall be debited under following head of account:
