### ORDER:-

- 3. In the Government Order sixth read above, an amount of Rs.117.00 lakhs was released to the Madras Institute of Development Studies, Chennai as the Plan and Non Plan matching grant for the year 2014-2015 equal to the amount released by the ICSSR. New Delhi.
- 4. The ICSSR in its letter seventh and eighth read above has released an amount of Rs.53.00 lakhs being the 3<sup>rd</sup> installment of the Non Plan and fourth installment of Plan (Recurring) to the MIDS Chennai for the year 2014-2015. In the Government Order ninth read above, an amount of Rs.53.00 lakhs was released to the Madras Institute of Development Studies, Chennai as the Plan and Non Plan matching grant for the year 2014-2015 equal to the amount released by the ICSSR, New Delhi.

The ICSSR in its letter tenth read above the ICSSR has released an amount of Rs.43.00 lakhs towards the Non Plan recurring grant being the 4<sup>th</sup> installment for the year 2014-15 as detailed below and the MS SPC in his letter eleventh read above, has requested the Government to release the State's share of fourth installment of Non-Plan recurring Grant to Madras Institute of Development Studies, on matching basis, for the year 2014-2015.
