**ORDER:**

In the Government order first read above, administrative sanction was accorded for Rs. 340.00 lakhs (State Component Rs. 240.00 lakhs + UNDP-UPC Component Rs. 100.00 lakhs) for the preparation of State / District Human Development Report from January 2013 to December 2016 under the United Nations Development Programme (UNDP) - Union Planning Commission (UPC) Project, Human Development ; Bridging Inequalities (HDBI) Project and also accorded financial sanction of Rs. 105.50 lakhs (State Component Rs. 72.00 lakhs + UNDP-UPC Component Rs. 33.50 lakhs) for the year 2013-14 to carry out the above works.

2. In the Government order second read above, the Government have accorded financial sanction of Rs.174.50 lakhs (State Component Rs.117.00 lakhs + UNDP-UPC Component Rs. 57.50 lakhs) for the preparation of State / District Human Development Report and Human related activities for the year 2014-2015.

3. In the Government order third read above, the Government have accorded financial sanction of Rs.129.80 lakhs (State Component Rs.61.00 lakhs + UNDP-UPC Component Rs. 68.80 lakhs) for the preparation of State / District Human Development Report and Human related activities for the year 2015-2016.

4. In the Government Order fourth read above, the Government have issued amendment to the above Government Order to utilize Rs.6.00 lakhs for taking up a single and comprehensive study on Health, Education and Livelihood status of tribals in 7 Districts instead of taking up the research studies of Nutritional Status of Children and Status of Education at Rs.3.00 lakhs each.

5. In the Government order fifth read above, the Government have accorded financial sanction of Rs.144.42 lakhs (State Component Rs.64.90 lakhs + UNDP-UPC Component Rs. 79.52 lakhs) for the preparation of State / District Human Development Report and Human related activities for the year 2016-2017.

6. In the letter sixth read above, the Member Secretary, State Planning Commission has, therefore, requested the Government to sanction an amount of Rs.30.00 lakhs from the State component for the year 2017-18 for the spill over below activities:

7. The Government after careful consideration accept the proposal of the Member-Secretary, State Planning Commission and accordingly sanction a sum of Rs.30 lakhs (Rupees Thirty lakhs only) from the state component for the preparation of State / District Human Development Report and Human Development related activities for the year 2017-2018, under the Human Development; Bridging Inequalities Project (HDBI).

Pending provision of such funds, the Member Secretary, State Planning Commission is authorised to draw and disburse the amount sanctioned in para – 7 above. This expenditure shall be brought to the notice of Legislature by specific inclusion in the Supplementary Estimates 2017-18. The Member – Secretary, State Planning Commission is also requested, shall include the above item of expenditure while sending the budget proposal for RE/FMA 2017-18 to Finance (Public/BG-I) Department at the appropriate time without fail.
