In the Government Orders first and second read above, the Government of Tamil Nadu have agreed to sanction matching grant equal to the amount sanctioned by the Indian Council of Social Science Research (ICSSR) to the Madras Institute of Development Studies, Chennai every year.

In the Government Order fourth read above, the Government has sanctioned an amount of Rs.120.68 lakhs (Plan Grant Rs.48 lakhs and Non-Plan Grant Rs.72.68 Lakhs) as the first and second installments to the Madras Institute of Development Studies as matching grant for the year 2013-2014. In the Government Order fifth read above, the Government has sanctioned an amount of Rs.35 Lakhs, as third installment to the Madras Institute of Development Studies, as matching grant for the year 2013-2014. In the Government Order sixth read above, the Government has sanctioned an amount of Rs.37 Lakhs, as fourth installment to the Madras Institute of Development Studies, as the matching grant for the year 2013-2014. Totally, a sum of Rs.192.68 lakhs has been released to the MIDS for the year 2013-2014 based on the releases made by the ICSSR, New Delhi.

3. The Director, Madras Institute of Development Studies, in his letter eighth read above, has requested to consider the one time additional matching grant of Rs.3.00 lakhs for IT infrastructure, on par with the funds released by the ICSSR for the year 2013-2014.

4. The Government after careful consideration, accord sanction for release of a sum of Rs.3.00 lakhs (Rupees three lakhs only) equal to the amount released by the ICSSR, New Delhi as the one time additional matching grant of Rs.3.00 lakhs on matching basis, for the year 2013-2014..

The expenditure sanctioned in Para.4 above shall be debited under the head of account // "3475 00 Other General Economic Services – 800 Other Expenditure | Non-Plan – AI Grants to Madras Institute of Development Studies – 09.Grants in aid-01.Grants for Current Expenditure" (DPC 3475 00 800 AI 0910)//

The Member-Secretary, State Planning Commission is authorized to draw and disburse the amount sanctioned in para.4 above to the Madras Institute of Development Studies, Chennai, from out of the funds provided in BE 2015-2016 under proper acknowledgement and watch the receipt of the utilization certificate from the above institute.
