#### **ORDER :**

In the Government Order first read above, orders have been issued to amend the Special Rules for Class XLIII of the Tamil Nadu General Sub-ordinate Service (Section 13 under Part II of the Service Rules in Volume-III of the Tamil Nadu Services Manual, 1969) prescribing minimum tenure of experience for promotion as Statistical Inspector from the category of Assistant Statistical Investigator among other things.

2. Now, the Principal Secretary/Commissioner, Department of Economics and Statistics has stated that in view of the above said amendment to the said Special Rules, there is difficulty in filling up the post of Statistical Inspector from the feeder category of Assistant Statistical Investigator by virtue of prescription of 5 years experience in the post of Assistant Statistical Investigator which include 3 years field experience in district other than Chennai in collection of statistical Data.

3. The Principal Secretary/ Commissioner, Department of Economics and Statistic has therefore requested the Government to issue suitable amendment to the Special Rules for Class XLIII of Tamil Nadu General Subordinate Services prescribing experience in the post of Assistant Statistical Investigator in such a way that the total experience in the post of Assistant Statistical Investigator shall be 3 years of which the field experience be 2 years instead of the existing 5 years total experience of which 3 years be field experience.

3. Government after careful consideration, accept the proposal of the Principal Secretary/Commissioner, Department of Economics and Statistics and decided to issue suitable amendments to the Special Rules for Class XLIII of the Tamil Nadu General Subordinate Services.

The following Notification will be published in the Tamil Nadu Government Gazette:-

**NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for CLASS XLIII of the Tamil Nadu General Subordinate Service (Section 13 under Part-II of the Service Rules in Volume-III of the Tamil Nadu Services Manual, 1969).

2. The amendments hereby made shall come into force with effect on and from the date of publication of the Notification.

**AMENDMENTS**

In the said Special Rules , in part -II, in Class XLIII-ECONOMICS AND STATISTICS DEPARTMENT, in rule 4, in THE TABLE, in item 2 in column (3) against the entry "promotion" in column (2) and the entry "Statistical Inspectors" in column (1) thereof,-

(a) for the expression "five years" the expression "three years" shall be substituted.

(b) for the expression "three years" in the second proviso, the expression "two years" shall be substituted.
