ORDER:

In the Government Order read above, Government constituted a State Level Coordination Committee under the Chairmanship of Additional Chief Secretary, Planning Development and Special Initiatives Department in order to ensure timely completion of Ninth Agricultural Census work.

2. In the letter second read above, Government of India have requested to constitute a State Level Coordination Committee (SLCC) in the State and have its meeting convened on regular intervals so that impediments in completion of different constituent activities of Agriculture Census 2015-16 could be discussed and sorted out for timely completion along with Committees at District level by including representatives from District authorities of Revenue, Agriculture, Economics and Statistics Departments. In the letter third read above, the Principal Secretary/Commissioner, Department of Economics and Statistics has therefore, requested the Government to constitute a State Level Coordination Committee (SLCC) to monitor the constituent activities of the Tenth Agricultural Census and also to fix targets for inspection to the supervisory officials in connection with the Tenth Agricultural Census 2015-16.

3. Government after careful consideration, constitute a State Level Coordination Committee under the Chairmanship of Principal Secretary to Government, Planning Development and Special Initiatives Department in order to ensure timely completion of Tenth Agricultural Census work. The composition of the State Level Coordination Committee shall be as follows:

1.	Principal Secretary to Government, Planning Development and Special Initiatives Department, Chennai-9.	Chairman
2.	Principal Secretary/Commissioner, Department of Economics and Statistics, Chennai-6.	Member Secretary
3.	Additional Chief Secretary/Commissioner, Land Administration Department, Chennai-5	Member
4.	Commissioner of Agriculture, Chennai-5.	Member
5.	Senior Technical Director, National Informatics Centre, Chennai-90.	Member
6.	Deputy Director General, Ministry of Agriculture and Farmers Welfare, Department of Agriculture, Co-operation and Farmers Welfare, Krishi Bhavan, New Delhi.	Member

4. Government have also fixed the following targets for inspection to the supervisory officials who are involved in the Agriculture Census work:

Sl.No.	Designation	Target
1.	District Revenue Officer	5 villages @ one in a month
2.	Revenue Divisional Officer	5 villages @ one in a month
3.	Tahsildhar/Deputy Tahsildhar	5 villages
4.	Revenue Inspector	5 villages
5.	Regional Joint Director of Statistics	15 villages
6.	District Deputy Director of Statistics	20 villages
7.	Divisional Assistant Director of Statistics	15 villages

5. Government also directs that the Village Administrative Officers shall be made responsible for the collection of primary data of the State from the Village Land Records on reclassification basis and the field work shall be inspected by the concerned Supervisory Officials of the Revenue Department. Moreover, the District Revenue Officers are the overall supervisory authority of Revenue records. They are designated as District Agricultural Census Officers and the concerned Tahsildars are designated as Taluk Agricultural Census Officers and they would be held responsible for the Agriculture Census work in their respective Districts/Taluks.
