ORDER:

In the Government Order first read above, Government constituted the expert group for the estimation and compilation of Gross State Domestic Product / Net State Domestic Product compiled with the base year 2011-2012 and also accorded sitting fees of Rs.2000/- per sitting to the five Non- Official Members of Expert Group.

2. In the letter second read above, the Additional Chief Secretary/ Commissioner, Department of Economics and Statistics has requested the Government to provide sitting fees to the Non-Official members of the Expert Group and to sanction an amount of Rs.1,20,000/- per year from 2018-2019 onwards.

3. The Government after careful examination, has decided to sanction a sum of Rs.1,20,000/- (Rupees One lakh and twenty thousand only) towards sitting fees to the Five Non-Official members of the Expert Group constituted for the estimation and compilation of Gross State Domestic/Net State Domestic product from 2018-2019 onwards.
