## **ORDER:**

In the Government Order read above, orders were issued sanctioning an amount of Rs.13,95,000/- for conduct of Crop Cutting Experiment Refresher Training in all 385 blocks at Rs.3600/- each and for headquarters at Rs.9000/- for the year 2017-2018.

2. In the letter read above, the Principal Secretary/Commissioner, Department of Economics and Statistics has stated that the productivity and production of agricultural crops in Tamil Nadu is estimated through crop cutting experiments under the crop estimation surveys. The Department of Economics and Statistics is designated as State Agriculture Statistics Authority (SASA) for planning and organizing the survey. Refresher training is imparted to field staff and supervisory staff in districts in the beginning of every Fasli year. Hence, the Principal Secretary/Commissioner, Department of Economics and Statistics has requested the Government to provide an amount of Rs.13,95,000/- as recurring expenditure for every year to conduct Crop Cutting Experiment Refresher Training in all 385 blocks at Rs.3600/- each and for headquarters at Rs.9,000/-.

3. The Government after careful consideration accept the proposal of the Principal Secretary/Commissioner, Department of Economics and Statistics for conducting Crop Cutting Experiment Refresher Training in all 385 blocks at Rs.3600/- each and for headquarters at Rs.9,000/- and accord sanction for a sum of

Rs.13,95,000/- (Rupees Thirteen lakhs ninety five thousand only) as a recurrent expenditure from the current year 2018-2019 onwards, as detailed in the Annexure.

4. The expenditure shall be debited under the following Head of Account:

“3454 - Census Surveys and Statistics - 02 Surveys and Statistics 110. Gazette and Statistical Memoirs – States Expenditure - AE. Integrated Scheme for Development of Statistics - 72.Training” (DPC 3454-02-110-AE-7202).

5. Necessary additional funds of Rs.13,95,000/- will be provided in Revised Estimate/Final Modified Appropriation 2018-2019. However, this expenditure shall be brought to the notice of the Legislative by Specific Inclusion in the Supplementary Estimate 2018-19. Pending provision of such funds in Revised Estimate/Final Modified Appropriation 2018-2019, the Principal Secretary/Commissioner, Department of Economics and Statistics is authorized to draw and disburse the amount sanctioned in para 3 above. The Principal Secretary/Commissioner, Department of Economics and Statistics is also requested to include the expenditure while sending budget proposals for Revised Estimate/Final Modified Appropriation 2018-2019 and also send necessary draft explanatory note for Inclusion of this expenditure in the Supplementary Estimate 2018-2019 to Government in Finance (BG-I/Public) Department at the appropriate time without fail.
