## ORDER:

In the Government Orders first and second read above, the Government of Tamil Nadu have agreed to sanction matching grant equal to the amount sanctioned by the Indian Council of Social Science Research (ICSSR) to the Madras Institute of Development Studies, Chennai every year.

The Indian Council of Social Science Research, in its letter fourth and fifth read above, has released an ad-hoc grants of Rs.22.30 lakhs (Rs.4.30 lakh under General and Rs.18.00 lakh under Salary Head) being the 1<sup>st</sup> installment to Madras Institute of Development Studies. This amount will be adjusted in regular annual allocation of Grant under General (OH 31) and Salary (OH 36) grant for the current financial Year as detailed below.

In this connection, the Member Secretary, State Planning Commission in his letter sixth read above, has requested the Government to release the State's share of Grant under General (OH 31) and Salary (OH 36) grant to Madras Institute of Development Studies, on matching basis, for the year 2017-2018.
- 4. The Government after careful consideration, accord sanction and release a sum of Rs.22.30 lakhs (Rupees Twenty Two Lakhs and Thirty thousand only) on Adhoc basis equal to the amount released by the ICSSR, New Delhi as the first Installment to the Madras Institute of Development Studies, Chennai, being the State's matching share for the year 2017 2018 as detailed at para 2 above.
- 5. The expenditure sanctioned in Para-2 above shall be debited to under the head of account "3475 00 Other General Economic Services 800 Other Expenditure State's Expenditure Al Grants to Madras Institute of Development Studies 09. Grants in aid- 01. Grants for Current Expenditure (DPC 3475 00 800 Al 0910)".
- 6. The Member-Secretary, State Planning Commission is requested to draw and disburse the amount sanctioned in Para-4 above to the Madras Institute of Development Studies under proper acknowledgement and watch the receipt of the Utilization Certificate from the above Institute.
