**ORDER:**

The State Planning Commission has recommended the proposal of implementing the E-evaluation System in the Evaluation and Applied Research Department at a total cost of Rs.62.46 lakh under Tamil Nadu Innovation Initiatives (TANII) Schemes for the year 2016-2017, 2017-2018 and 2018-2019.

2) The Standing Finance Committee has approved the proposal for Implementation of the E-evaluation System in the Evaluation and Applied Research Department as recommended by the State Planning Commission at a total cost of Rs. 62.46 lakh under Tamil Nadu Innovation Initiatives (TANII) Schemes for the years 2016-2017, 2017-2018 and 2018-2019.

3) A sum of Rs.41.00 lakh was sanctioned for the year 2016-17 in G.O. 2<sup>nd</sup> read above and a sum of Rs.10.80 lakh was sanctioned for the year 2017-18 in G.O. 3<sup>rd</sup> read above.

4) In the reference 4<sup>th</sup> read above, the Director (FAC), Evaluation and Applied Research Department has requested to sanction the balance of Rs.10,66,000/- for the third year 2018-2019 under various components for the E-evaluation System.

5) The Government accordingly sanction a sum of Rs.10,66,000/-(Rupees Ten lakhs sixty six thousand only) for Implementation E-evaluation System under Tamil Nadu Innovation Initiatives (TANII) for the third year 2018-2019.

6) The expenditure sanctioned in Para 5 above shall be debited under following head of account:

“3475-00-Other General Economic Services – 800 – Other Expenditure – State’s Expenditure – JK E-evaluation System up- gradation - Schemes under State Innovation Fund – 09 – Grants in aid – 03 – Grants for Specific Schemes” (DPC 3475-00-800-JK-0935).

The above expenditure shall be met from the State Innovation Fund by a deduction under the head of account Demand No.36 HOD 03:

“J Reserve Fund (b) Reserve Fund not bearing Interest – 8229 00 Development and Welfare Funds 200 Other Development and Welfare Fund – BE State Innovation Fund – BE State Innovation Fund” (DPC 8229 00 200 BE 0006) (outgo)

7) The Director (FAC), Evaluation and Applied Research Department, is the Estimating, Reconciling and Controlling authority for the above head of account.

8) Necessary additional funds will be provided in Revised Estimate/Final Modified Appropriation 2018-2019. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimate 2018-2019. Pending provision of such funds in Revised Estimate/Final Modified Appropriation 2018-2019, the Director (FAC), Evaluation and Applied Research Department is authorized to draw and disburse the amount sanctioned in para 5 above. He is also

directed to include this item of expenditure while sending the budget proposal for Revised Estimate/Final Modified Appropriation 2018-2019 and also send necessary draft explanatory note for inclusion of this expenditure in the Supplementary Estimate 2018-2019 to Government in Finance (BG.I/Public) Department at the appropriate time without fail.
