ORDER:

In Government Order first read above orders have been issued for the formation of High Level Coordination Committee (SLCC) on Crop Estimation Survey (CES) and State Level Co-ordination Committee on Annual Survey of Industries (ASI) under the Chairmanship of the Principal Secretary/Commissioner, Department of Economics and Statistics. The HLCC has conduct a meeting on Crop Estimation Survey (CES) twice in a year to assess the progress of the work relating to the Crop Estimation Survey (CES) and other matters connected therewith and to discuss the following subjects.

- i. Prime Minister Fasal Bhima Yojana
- ii. Crop Estimation Survey on Minor Crops
- iii. Fruits and Vegetables Survey
- iv. Improvement of Crop Statistics
- v. Timely Reporting Scheme, and related issues regarding collection and compilation of Agricultural Statistics in the State.

2. The Commissioner, Department of Economics and Statistics in his letter second read above has stated that to all the above agriculture schemes are based on the details available in the village records viz., 1,1A, A Register, Adangal, FMB etc. Estimation on the production of various agriculture products are based on the Crop Cutting Experiments conducted by the field staff of Agriculture and Department of Economics and Statistics. The data available in the village records viz survey number, name and area of the crop cultivated in each season, Field Measurement Book are essential for the selection of plot to conduct CCEs for various crops. The basic objective of the Central Sector Scheme of ICS is to minimize the gap between the area reported by the Supervisor after field visit and the area reported by the Village Administrative Officer. Timely updation of data for each season proper maintenance of the village records and the co-operation of the Village Administrative Officers are very essential for the effective implementation of all the above schemes. Absence of updation and proper maintenance of village records causes delay and discrepancies in the data collected from various village records.

3. The Commissioner, Department of Economics and Statistics has suggested that the committee may be reconstituted by including the Commissioner, Revenue Administration, the Commissioner, Land Administration, the Director, Horticulture Department, the Director of Sugar and Representative from Tamil Nadu Agricultural University (TNAU), Coimbatore as members. Since all the schemes are related to agriculture, the committee may be renamed as High Level Co-ordination Committee on Agricultural Statistics.

4. The Government have accordingly decided to rename the High Level Coordination Committee on Crop Estimation Survey as High Level Coordination Committee on Agricultural Statistics and reconstitute the Committee as follows:

5. The High Level Coordination Committee (HLCC) on Agriculture Statistics will meet once in a year.


