ORDER:

The State Planning Commission has recommended the proposal on Developing Software for Data Management Cell for monitoring and implementation of Sustainable Development Goals (SDGs) under Tamil Nadu Innovation Initiatives (TANII) Scheme for the year 2018-19 (Round-II) at a total outlay of Rs.16.30 lakhs to be implemented during the year 2018-19 and 2019-2020.

2. The Member Secretary, State Planning Commission has stated in the letter read above that a meeting under the Chairmanship of the Additional Chief Secretary to Government, Planning and Development Department has been held on 29-1-2019 in Secretariat with the Commissioner, Tamil Nadu e-Governance Agency among others, on the issue of developing a Web portal Monitoring Information System to monitor the implementation of Sustainable Development Goals, Vision 2023, Tamil Nadu Innovation Initiatives, State Balanced Growth Fund, Special Area Development Programme and other schemes. In that meeting, it has been further decided that the development of Web portal may be entrusted with the Commissioner of Tamil Nadu e-Governance Agency for which the Commissioner of Tamil Nadu e-Governance Agency has been requested to submit a proposal to the Member Secretary, State Planning Commission.

3. The Member Secretary, State Planning Commission, has stated that the Commissioner, Tamil Nadu e-Governance Agency has submitted a proposal at a cost of Rs.24.20 lakhs for the development of Web portal Application. He has therefore suggested that out of a sum of Rs.24.20 lakhs requested by the Tamil Nadu e-Governance Agency for

the development of Web portal Application, a sum of Rs.16.30 lakhs approved under Tamil Nadu Innovation Initiatives for the year 2018-19 (Round-II) under the State Planning Commission Head of Account may be transferred initially to the Tamil Nadu e-Governance Agency. The balance amount of Rs.7.90 lakhs may be transferred to the Tamil Nadu e-Governance Agency out of the amount Rs.45.00 lakhs approved for the Evaluation and Applied Research Department under Tamil Nadu Innovation Initiatives for the year 2018-19 (Round-II).

4. After careful examination of the proposal of Member Secretary, State Planning Commission, and also taking into consideration of the proposal of Commissioner, Tamil Nadu e-Governance Agency, the Government sanction a sum of Rs.16,30,000/- (Rupees Sixteen Lakhs and Thirty Thousand only) for the development of Web portal application for monitoring the implementation of Sustainable Development Goals, Tamil Nadu Innovation Initiatives, State Balanced Growth Fund and Special Area Development Programme etc.

5. Government hereby release a sum of Rs.11,50,000/- (Rupees Eleven Lakhs and Fifty Thousand only) for the year 2018-19 for the above mentioned scheme for which necessary provision has been made in the Final Supplementary Estimates 2018-19.

6. Government also hereby release a sum of Rs.4,80,000/- (Rupees Four Lakhs and Eighty Thousand only) during the financial year 2019-20 for which necessary funds have been provided in BE 2019-20. The sanctioned amount of Rs.4,80,000/- shall be drawn only after 01-04-2019.

7. The expenditure sanctioned in paragraphs 5 and 6 above shall be debited under the following head of account:

8. The above expenditure shall be met from the State Innovation Fund by a deduction under the head of account Demand No.36 Head of Department 04:
