ORDER:

In the letter read above, the Principal Secretary/Commissioner, Department of Economics and Statistics has stated that the productivity and production of agricultural crops in Tamil Nadu is estimated through crop cutting experiments under the crop estimation surveys. The Department of Economics and Statistics is designated as State Agriculture Statistics Authority (SASA) for planning and organizing the survey. Refresher training is imparted to field staff and supervising staff in districts in the beginning of every Fasli year. Hence, the Principal Secretary/Commissioner, Department of Economics and Statistics has requested the Government to provide an amount of Rs.13,95,000/- as recurring expenditure every year for conduct of Crop Cutting Experiment Refresher Training in all 385 blocks at Rs.3600/- each and for headquarters at Rs.9,000/-. He has also requested the Government to provide this amount as an additional item of expenditure during 2017-2018, since the budget allocation of Rs.91,000/- provided under the Head of Account 3454-02-110-AE-7202.

2. The Government after careful consideration, accept the proposal of the Principal Secretary/Commissioner, Department of Economics and Statistics for conducting Crop Cutting Experiment Refresher Training in all 385 blocks at Rs.3600/each and for headquarters at Rs.9,000/-and accord sanction a sum of Rs.13,95,000/-(Rupees Thirteen lakhs ninety five thousand only) as a recurring expenditure from the current year 2017-2018 onwards, as detailed in the Annexure.

3. The expenditure shall be debited under the following Head of Account:

"3454- Census Surveys and Statistics -02 Surveys and Statistics 110. Gazette and Statistical Memoirs - State's Expenditure - AE. Integrated Scheme for Development of Statistics - 72.Training" (DPC. 3454-02-110-AE-7202).

- 4. Necessary additional funds of Rs.13,95,000/- will be provided in Revised Estimate/Final Modified Appropriation 2017-2018. Pending provision of such funds in Estimate/Final Modified Appropriation 2017-2018, the Principal Secretary/Commissioner, Department of Economics and Statistics is authorized to draw and disburse the amount sanctioned in para-2 above. This expenditure shall be brought to the notice of Legislature by way of specific inclusion in the Supplementary Estimates 2017-2018. The Principal Secretary/Commissioner Department of Economics and Statistics, should include the amount sanctioned in para-2 above while sending budget proposal to Government for inclusion in Revised Estimate/Final Modified Appropriation 2017-2018 without fail. The Principal Secretary/Commissioner Department of is also requested to send necessary explanatory notes to **Economics and Statistics** Finance (BG-I/ Public) Department for inclusion of Supplementary Estimates 2017-2018.
