ORDER :

In the Government Orders first and second read above, the Government of Tamil Nadu have agreed to sanction matching grant equal to the amount sanctioned by the Indian Council of Social Science Research (ICSSR) to the Madras Institute of Development Studies (MIDS), Chennai every year.

In G.O.Ms.No.60, Planning, Development and Special Initiatives (SPC) Department, Dated: 19.7.2018, Government have sanctioned and released a sum of Rs.52.30 lakhs (Salary Grant Rs.43.50 lakhs + General Grant Rs.8.80 lakhs) to Madras Institute of Development Studies as fifth instalment for the financial year 2017-2018.

3. The Indian Council of Social Science Research in its letter 4th read above has released additional matching grant of Rs. 10.00 lakh to Madras Institute of Development Studies for the financial year 2017-2018 based on the equivalent amount released by Indian Council of Social Science Research, New Delhi. The additional matching grant to the Madras Institute of Development Studies, Chennai, being the State's matching share for the year 2017-2018 is as detailed below :-

4. The Member Secretary, State Planning Commission in the reference 5th read above, has requested the Government to release the sum of Rs. 10.00 lakh to Madras Institute of Development Studies being the additional matching grant for the financial year 2017-2018.

5. Government after careful consideration, accord sanction and release the State's share of additional matching grant of Rs. 10.00 lakh (Rupees Ten Lakhs only) to Madras Institute of Development Studies for the financial year 2017-2018 based on the equivalent amount released by Indian Council of Social Science Research, New Delhi.

6. The expenditure sanctioned in para-5 above shall be debited under the head of account "3475.00 Other General Economic Services – 800 Other Expenditure - State's Expenditure – AI Grants to Madras Institute of Development Studies – 09.Grants in aid- 01.Grants for Current Expenditure(DPC 3475 00 800 AI 0910)".

7. Necessary additional funds of Rs.10,00,000/- will be provided in RE/FMA 2018-2019. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates 2018-2019. Pending provision of such funds, the Member Secretary, State Planning Commission is authorized to draw and disburse the amount sanctioned in para 5 above. He is also directed to include this item of expenditure while sending the budget proposal for RE/FMA 2018-19 and also send necessary draft explanatory note for inclusion of this expenditure in the Supplementary Estimate 2018-2019 to Government in Finance (BG-I/PUBLIC) Department at the appropriate time without fail.
