ORDER:

In the letter read above, the Principal Secretary/Commissioner, Department of Economics and Statistics has sent a proposal to the Government to form the Expert Group for the estimation and compilation of Gross State Domestic Product / Net State Domestic product have been compiled with the base year as 2011-12. The new series of the Gross State Domestic Product/Net State Domestic Product estimates compiled with the base year as 2011-2012 and the estimates are being sent to Central Government and other State Governments and also to various other Departments. The Central Statistics Office has taken up the preliminary work for the new base 2017-2018 and as a part of base revision exercise, it has stressed the need for the States to carry out requisite State level sample surveys and type studies to improve the reliability of national level estimates.

2. The Government after careful examination, has decided to constitute of the expert group for the estimation and compilation of Gross State Domestic Product / Net State Domestic product compiled with the base year as 2011-12 and ordered accordingly. In order to understand the insight of various parameters involved in the estimation procedure of State Gross Domestic Product and also to analyze the methodological aspects on the compilation of Advance Estimates.
