In reference first read above the Additional Chief Secretary/Commissioner, Department of Economics and Statistics has referred to the minutes of the 23rd COCSSO (Conference of Central and States Statistical Organisations) meeting held on 04.11.2015 and 05.11.2015 at Guwahati wherein it was recommended that State's Department of Economics and Statistics should constitute an Expert Committee to finalise the Pooled results of Central and State sample data of National Sample Surveys.

2. Accordingly to implement the Conference of Central and States Statistical Organisations recommendations, an Expert Committee for the above purpose under the Chairmanship of the Additional Chief Secretary/Commissioner, Department of Economics and Statistics, with following members had been constituted to validate the results of Central and State Sample relating to the National Sample Survey.

5. Any other special invitees (Member)

The Additional Chief Secretary/ Commissioner, Department of Economics and Statistics has stated that the Committee will validate the pooled results of Central and State sample data of National Sample Surveys and will give advice/suggestions, necessary and approve the results and also the Expert Committee meeting is to be conducted once in 3 months or as and when required. The External invitees attending the meeting may be paid honorarium @ Rs. 1500/- per day. Lunch and refreshments may also be provided to the Expert Committee members who attend the meeting.
