ORDER:

In the letter read above, the Principal Secretary/Commissioner, Department of Economics and Statistics has stated that the productivity and production of agricultural crops in Tamil Nadu is estimated through crop cutting experiments under the crop estimation surveys. The Department of Economics and Statistics is designated as State Agriculture Statistics Authority (SASA) for planning and organizing the survey. Refresher training is imparted to field staff and supervising staff in districts in the beginning of every Fasli year. The Principal Secretary/Commissioner, Department of Economics and Statistics has requested the Government to provide an additional amount of Rs.13,04,000/-for conduct of Crop Cutting Experiment Refresher Training in all 385 blocks at Rs.3600/- each and for headquarters at Rs.9,000/- for the year 2016-2017.

2. The Government after careful consideration accept the proposal of the Principal Secretary/Commissioner, Department of Economics and Statistics and accordingly sanction a sum of Rs.13,95,000/- (Rupees Thirteen lakhs ninety five thousand only) for conducting Crop Cutting Experiment Refresher Training in all 385 blocks at Rs.3600/- each and for headquarters at Rs.9,000/- for the year 2016-2017, as detailed in the Annexure.

3. The expenditure shall be debited under the following Head of Account:

“3454- Census Surveys and Statistics -02 Surveys and Statistics 110. Gazette and Statistical Memoirs -I. Non-plan - AE. Integrated Scheme for Development of Statistics - 72.Training” (DPC. 3454-02-110-AE-7202).
