### ORDER:

The Commissioner of Economics and Statistics, in the letter 4<sup>th</sup> read above, has stated that a sum of Rs.390.00 lakhs was approved under Tamil Nadu Innovation Initiatives (TANII) for the conduct of Household Panel Survey jointly by the Department of Economics and Statistics (DOES) and Madras Institute of Development Studies (MIDS) with the technical support of Survey Research Centre, University of Michigan, U.S.A., for which funding support was assured under Tamil Nadu Innovation Initiatives (TANII) covering three years from 2015-2016 to 2017-18. Out of the approved amount of Rs.390.00 lakhs a sum of Rs.10.00 lakhs was released in the Government Order 1<sup>st</sup> read above and a sum of Rs.250.00 lakhs was released in the Government Orders 2<sup>nd</sup> and 3<sup>rd</sup> read above. Out of Rs.260.00 lakhs released, a sum of Rs.1,47,46,995/- was incurred as of date, out of which the share of expenditure of Department of Economics and Statistics was Rs.8,51,168/- and the share of expenditure of MIDS was Rs.1,38,95,827/-. The balance unspent amount of Rs.1,12,53,005/- was remitted into Government account in May, 2018.

- 2. Now, the Department of Economics and Statistics has submitted a proposal for Rs.1.69 crores out of the balance amount of Rs.2.43 crores for the activities undertaken already and to be taken up during the financial year 2018-19.
- 3. Based on the multiple discussions, the additional work already done and due to be taken up in the first few months of 2019-20 by the MIDS, it has been decided that initially a sum of Rs.50.00 lakhs be released to MIDS during the current financial year 2019-20. The remaining amount required for the years 2019-20 and 2020-21 by the Department of Economics and Statistics and Madras Institute of Development Studies will be released on receipt of the proposals from the Department of Economics and Statistics taking into consideration of the progress of the activities connected with the said survey.
- 4. Taking into consideration that any delay in timely release of funds for the conduct of Household Panel Survey will result in escalation of cost, it has now been decided to release a sum of Rs.50 lakhs to MIDS during the current financial year 2019-20.
- 5. Government after careful consideration sanction a sum of Rs.50,00,000/-(Rupees Fifty Lakhs only) towards conduct of Household Panel Survey to Madras Institute of Development Studies, during the current financial year 2019-20.
- 6. The expenditure sanctioned in para-5 above shall be debited under the head of account

8. Necessary additional funds will be provided in RE / FMA 2019-20. Pending provision of such funds, the Commissioner of Economics and Statistics is authorized to incur the expenditure sanctioned in para 5 above. The Commissioner of

Economics and Statistics is requested to include the above item of expenditure while sending the budget proposal for RE/FMA 2019-2020 to Finance Department without fail. The expenditure shall be brought to the notice of the Legislature by specific inclusion in the Supplementary Estimates 2019-20. The Commissioner of Economics and Statistics is requested to send necessary draft explanatory note for inclusion in Supplementary Estimates at the appropriate time without fail to Finance Department.
