### ORDER:

In the Government Order first read above, Government have constituted a High Level Committee under the Chairmanship of Chief Secretary for Aspirational Districts Programme and nominated the following two State Level Nodal Officers for each of the Districts to act as a bridge between the Centre and the District for the Aspirational Districts Programme.

- (i) Tmt. P. Amudha, IAS., for Ramanathapuram District
- (ii) Dr. Santhosh Babu, IAS., for Virudhunagar District
- 2. Monitoring Officers are being appointed to each District of the State by Government in Public Department, to review / inspect major schemes and programmes in the Districts and provide necessary suggestions / solutions to the respective District Officials to sort out the bottlenecks and pave way for speedy implementation of the programmes.

The Monitoring Officers are to visit the Districts allotted to them once in a month and ensure that their inspections and reviews in the districts are purposeful and result oriented.

- 3. In order to avoid an officer visiting two districts and two officers coming to review one particular district (State Nodal Officer of Aspirational District and Monitoring Officer) orders of Chief Secretary were obtained and accordingly at present the Monitoring Officer for the District is being nominated as the State Nodal Officer (State Prabhari Officer) for the District.
- 4. Consequent on the above, being Monitoring Officers for the respective districts, Thiru. Dharmendra Pratap Yadav, IAS., and Thiru. Pankaj Kumar Bansal, IAS., were nominated as State Level Nodal Officers for Ramanathapuram and Virudhunagar Aspirational Districts respectively vide orders second and third read above.
- 5. Thiru. Dharmendra Pratap Yadav, IAS., Principal Secretary to Government, Handlooms, Handicrafts, Textiles and Khadi Department is the monitoring officer for Ramanathapuram District and shall continue as State Level Nodal Officer for Ramanathapuram Aspirational District.
- 6. In the Government order fourth read above, Dr. R. Anandakumar, IAS., Secretary, Welfare of Differently Abled Persons Department has been appointed as Monitoring Officer for Virudhunagar District.
- 7. In the Government order fifth read above, the services of Thiru. Pankaj Kumar Bansal, IAS., Principal Secretary/Chairman and Managing Director, Tamil Nadu Industrial Development Corporation Limited have been placed at the disposal of Government of India.
- 8. Accordingly, Government nominate Dr. R.Anandakumar, IAS., Secretary, Welfare of Differently Abled Persons Department as Monitoring Officer in the place of Thiru. Pankaj Kumar Bansal, IAS., as State Level Nodal Officer for Virudhunagar Aspirational District.
