ORDER:

In the letter sixth read above the Project Director, Hill Area Development Programme, Udhagamandalam has stated that a sum of Rs.10,97,124/- (Rupees Ten lakhs ninety seven thousand one hundred and twenty four only) is available as unspent under Medical and Public Health Sector due to the savings after completion of works and dropping of some works sanctioned in the Government Orders 1st to 5th read above from the period 2008 - 2009 to 2013 - 2014 and requested the Government to accord permission for utilization of the above amount by implementing various schemes in the Medical and Public Health Sector under Hill Area Development Programme in the Nilgiris District.

The Government after careful consideration accept the proposal of the Project Director, Hill Area Development Programme, Udhagamandalam and accord permission to utilize the sum of Rs.10,97,000/- (Rupees Ten lakhs and ninety seven thousand only) available as savings amount under Hill Area Development Programme funds for implementing schemes under Medical and Public Health Sector during 2014 - 2015. The details to be taken up for the above sanction are given in the annexure to this order.

- 3. The Collector of Nilgiris District is authorized to disburse the amount sanctioned in Para 2 above from the savings amount available from HADP funds over the years to the concerned implementing Department. The Project Director, Hill Area Development Programme, should maintain the accounts as per the existing procedure prescribed by the Government in force.
- 4. The Project Director, Hill Area Development Programme is requested to ensure that detailed estimates with project report are available for each item and Photographic evidence is obtained with the report (where relevant) and definitely after completion. The project report should identify and analyse user needs and the solution or part solution proposed, the alternative / additional funding sourced for the project for completion, if any. Further, the completion report should indicate facts of actual use and user benefits realised with photographic evidence. Finally a statement of account and refund of balances with interest accrued on Hill Area Development Programme funds should have been made or variations fully approved as required for Hill Area Development Programme projects.
- 5. The HOD / Sectoral Officers concerned are requested to implement the schemes effectively in consultation with Project Director, Hill Area Development Programme, Udhagamandalam and to send a report for the Completion of works to the Government.
